CONSTITUTION  
MEMORANDUM, RULES AND REGULATIONS  
OF THE INSTITUTE

1) Name :- Hutatma Smarak Samiti, will be the name of the Institute.

2) Place of Office :-  
The Head Office of the Institute will remain at and Post Ashti (Wardha)

3) Aims, Objects and Means :-

The aim of the Institute will be to perpetuate the memory of the martyrs of Freedom Movement Ashti through constructive work, irrespective of class, creed, caste or religion. Above mentioned aim will be attained by the following

means :-

- (A) To run the "Hutatma Rashtriya Vidyalays" and hostel if necessary.
- (B) To help the people in achieving all sided development through the Educational Vocational, Technical, Social, Cultural and Physical Institutes.
- (C) To facilitate the creation of literature, to maintain the National character for example History of Ashti Freedom Movement Kavya, Powade etc.
- (D) To run the Institutes right from the pre-primary Schools to College Education. Moreover to found the physical institute and Library.
- (E) To encourage the cottage industry, vocational and agricultural works.
- (F) To help in building the Memorial of the Martyrs of Ashti Freedom Movement and arrange fair and function in that connections

RULES - AND REGULATIONS OF  
ASHTI HUTATMA SMARAK SAMITI

(a) CONSTITUTIONS :-

It will have two bodies.

(A) General Body.

(B) Executive Body.

Kinds of Membership.

(a) Patrons - to donate 1001 or more than 1001 Rs

(2) Members of the A, B, C type will be the life members of the Samiti.

The period of membership of 'd' type will be for 5 years. Those who want to enter names in upper types of membership, can do so within the period of his membership by increasing their donations. (Only life members of A & B types will be liable for the Executive Body. Membership of D type will commence from the financial year of the Samiti.

(1) Rules and Regulations :-

Any person who is above 21 years old can be the member of the Samiti by applying to the Executive Body subject to the sanction by its simple majority. If the application is rejected the Executive Body is not bound to give the reasons of the rejection.

(2) The number of the members of the Executive Body will be from 7 to 11 lowest and highest respectively.

(3) The quorum of the Executive Body will be of 5 members. There is no necessity of the quorum for the adjourned meeting. The quorum of the General body will have 1/5 the members of its membership. The quorum is not necessary for the adjourned meeting of the general body.

(4) Ordinarily the notice of the meeting of the Executive Body will be given 3 days before. Emergency meeting will be held by the President or Secretary by giving a notice before 24 hours. Notice of the General Body will be given to the members 15 day.

(5) The President, Vice-Presidents and Secretary will be called as office bearers of the Samiti. In view of the work of the Samiti, President or Vice-Presidents and Secretary will be the residents of the head-quarters of Head Office of the Samiti. The President will have the power to decide the senior and Junior Vice-Presidents.

(6) Members of the Executive Body will be elected by the General Body. These elected members will elect their office bearers.

(7) In the absence of president, Vice-President, will conduct the meeting. If the both are absent, then the members of the Executive Body or General Body will elect their President for the time-being by simple majority.

(8) Shri K. V. Borade, Head Master of the "Hutatma Rashtriya High School" will be the exofficio member and Secretary of the



(9) The cash of the Samiti will be kept in the post office or Bank decided by the Executive Body by simple majority. The working president will have the power upto first election to withdraw the money, from the post office or Bank. The Secretary will keep in his hold a sum up to 200 (Two hundred) Rs. for rent expenses.

(10) The Executive Body will have the power to appoint a paid or honorary manager. If the Executive Body feels that the work of the Samiti demands it. Taking in view the scope of the work the executive Body can appoint sub committees and define the scope, rights, duties and rules of the sub-committees.

(11) The decision of the Executive Body will be taken by simple majority.

(12) The General Body will have the powers to amend the constitution by its 3/5 th (three fifth) votes if necessary, as per section no. 12 Registration Act, 1860.

(13) The president will have a casting vote in case of equal voting.

(14) The Executive Body may cancel the membership of a member of the Executive Body who remains absent for the three consecutive meeting without sufficient cause.

(15) The General Meeting of the Samiti will give its final sanction to the accounts of the previous year audited by the registered Auditor.

Duties of the Executive Body :-

(16) (1) To conduct the work of the Samiti in consonance with the aims and objects of the same.

(2) The President or Secretary will call the meeting of the Executive Body from time to time. There should be at least one meeting within 3 months.

(3) The Executive Body will maintain the accounts of the income and expenditure of Samiti. To appoint the registered auditor.

(4) To collect funds and to nominate honorary president if necessary.

(5) To appoint the servants if necessary and to make contract with them.

(6) To appoint or discontinue the teachers or servants of the "Butatma Vidyalaya" on the advice of the Head Master. Head Master can be discontinued by the 3/5th votes of the General Body as per Section 12 Registration Act, 1860.

(7) To appoint a School Committee.

(8) If the post is vacant in the Executive Body the Executive Body will fill up the post till the further election if

- (17) The financial year of the Samiti will be run with Rashtriya our year means Chaitra to Faifun (22nd March to 21st March).
- (18) The period of the Executive Committee will be of three years. Shri K. N. Borade and P. H. Sawalakhe Founder-member will be the permanent member of the Executive Body.
- (19) The Samiti will cancel the membership of any member for the indisciplinary behaviour or action contrary to the aims and objects of the Samiti.
- (20) The Executive Body will have the power to decrease or increase the number of the office bearers. The Samiti will have the authority to affiliate other institutions.
- (21) The English copy of the constitution will be the legs one.
- (22) The work " Samiti " is used for " Ashti Hutatma Smarak Samiti " in this constitution.
- (23) The first working Committee is appointed as below for three years :-

- (1) Shri Motilal Nawalkishore Bhargave of Ashti - President
- (2) Shri Marotrao Bhomaji Holey of Ashti - Vice-President.
- (3) --- Kashinath Vathuji Borade - Secretary of Ashti.
- (4) --- Pandurangrao Bhanji Sawalakhe of Ashti - Member.
- (5) --- Pandurangrao Bhanji Dhomene of Tarasawanga - Member.
- (6) --- Gunwantrao Bapurao Mohod of Ashti - Member.
- (7) --- Laxmanrao Abhimanji Wagh of Ashti - Member.
- (8) --- Bhaurao Sedashiv Bajare of Ashti - Member.
- (9) --- Onkar Appa Anya Appa Ganjiwale of Ashti - Member.
- (10) --- Jaglaa Ahyalal Jaiswal of Ashti - Member.

(22) The servant of 'Samiti' will be eligible for the simple membership of the 'Samiti' he should not be the member of the Executive Body. This rule will not be applicable to the Head Master of the "Hutatma Rashtriya Vidyalaya".

(25) (a) The Executive Body will have the power to accept the resignation of a member of the Executive Body or the servant of Samiti.

(b) The Executive Body will prepare and pass the budget for the running years.

(c) From the first election the Executive Body will have the power to decide the person or persons who will withdraw the cash from the post or Bank.
